### Request for sponsorship from the NWCC Performing Arts Center, Kerry Goff

Kerry Golf with the Northwest Community College presented information for a sponsorship request. Mr. Goff stated that this is a new facility, and they are excited about having a place to hold shows for community. Mr. Goff stated they will have a full schedule and programs for all ages. They are requesting the city sponsor some of the local talent.

Mayor Graves thanked Mr. Goff and advised him that we will give the Aldermen time to process this request, since he added it at the last minute.

#### Road Paving Project Update and Presentation – Mendrop/Civil Link

Greg Smith, Mendrop, stated that they have finalized the road study and are here to present their report.

Steve Bigalow, Civil Link, presented to the Mayor and Board of Aldermen the report of their road study. Mr. Bigalow stated that we have some bad roads, and some bad or weak soil in this area. The study was done using the Paser system, which is a recognized rating system. It's somewhat objective. Mr. Bigalow stated we had some good roads, some bad ones and a couple pretty bad ones. I believe 64% of your roads can be treated with either a crack seal, fog seal, micro surfacing, a thin lift or scrub seal. Mr. Bigalow went over the treatment costs. The process is that y'all will select the roads you want to treat and then as a Board decide how much you want to spend. At that point we can start the process. Mr. Bigalow stated that the maintenance cost is about 32% and the correction cost is about 68%. For everything that needs to be done to bring all of the streets up total of \$14,815,000 in 2022 dollars. Mr. Bigalow stated they normally prepare two budget cycle plans. They could do a 7-year cycle, where every road in the city will be addressed over 7 years and would be about \$2 million annually. Or they could do a 10-year cycle plan, where every road in the city will be addressed over 10 years and would be about \$1.4 million annually. We recommend doing the more traveled roads first. Once you decide how much you want to spend, we can help put a plan in place.

Mayor Graves asked Mr. Bigalow to explain to the Aldermen, as you did for me, why you don't go just fix the worse roads.

Steve Bigalow answered if you only fix your worse roads, the other will end up being the worse ones. Mr. Bigalow stated you'll need to invest in a maintenance plan. Maintenance the ones that are ok, not as bad, and fix some worse ones, every year.

Mayor Graves stated we need to digest the information and then come back to decide what we want to do.

Greg Smith stated yes, we can do a work session also if you'd like.

Alderman Dear asked how many miles of roads are in the city.

Steve Bigalow answered 54. You have some roads that would benefit from a chip and seal, and some would benefit from a brush and seal. A slurry seal usually lasts about 12 years.

Mayor Graves asked if anyone had any other questions. Mayor Graves thanked Mr. Smith and Mr. Bigalow for the information.

#### Set Medical Cannabis Permit Fee

Mayor Graves stated that Jim has found out some permit fee information about Hernando and Batesville. Alderman Moore, what was it that you heard.

Alderman Moore stated that the state said we could have a fee it just couldn't be unreasonable.

The Mayor and Board of Aldermen (the "Governing Body") of the City of Senatobia, Mississippi (the "City"), took up for consideration the matter of approving an extension and renewal to the City's existing non-revolving line of credit secured by a Taxable Loan Anticipation Note (Non-Revolving Line of Credit), dated July 22, 2021, of said City. After a discussion of the subject, Alderman Hale offered and moved for the adoption of the following resolution:

RESOLUTION APPROVING THE EXTENSION AND RENEWAL OF A NON-REVOLVING LINE OF CREDIT SECURED BY A TAXABLE LOAN ANTICIPATION NOTE (NON-REVOLVING LINE OF CREDIT), DATED JULY 22, 2021 (THE "2021 NOTE") OF THE CITY IN THE MAXIMUM PRINCIPAL AMOUNT OF NOT TO EXCEED NINE MILLION SIX HUNDRED SIXTY THOUSAND DOLLARS (\$9,660,000); APPROVING THE FORM OF THE AMENDED NOTE; AUTHORIZATING THE MAYOR AND CITY CLERK TO EXECUTE AND DELIVER DOCUMENTS NECESSARY TO EFFECTUATE THE PURPOSE OF THIS RESOLUTON, AND RATIFYING ACTIONS OF THE SAME HERETOFORE TAKEN ON BEHALF OF THE CITY; AND FOR OTHER RELATED MATTERS.

WHEREAS, the Governing Body of the City, acting for and on behalf of the City, hereby finds, determines, adjudicates and declares as follows:

 The City, by and through the Governing Body, has received a commitment from the United States Department of Agriculture - Rural Utilities Services ("USDA-RUS") for the improvement, repair and extension of the water, sewer and gas facilities of the combined water, sewer and gas system of the City (the "Loan").

2. The City is authorized by Section 21-33-326 et seq. of the Mississippi Code of 1972, as amended from time to time (the "Act") to borrow money in anticipation of receipt of funds from a confirmed loan, such as the Loan, from the United States of America, or an agency thereof, such as USDA-RUS, and may assign and pledge as security for such interim financing the proceeds of any such grant or loan.

3. On April 7, 2021, the City adopted a resolution (the "<u>Authorizing Resolution</u>") authorizing (i) the issuance of a non-revolving line of credit with an amount not to exceed \$9,660,000 and (ii) the execution and delivery of a Taxable Loan Anticipation Note for up to \$9,660,000.

4. On May 18, 2021, the City adopted a resolution (the "Sales Resolution") awarding the 2021 Note (as defined herein) to the Lender (as defined herein) and authorizing the execution and delivery of the 2021 Note.

5. On July 22, 2021, the City issued its Taxable Loan Anticipation Note (Non-Revolving Line of Credit), dated July 22, 2021, for an amount not to exceed \$9,660,000 (the "2021 Note") to Guaranty Bank & Trust Company, Belzoni, Mississippi (the "Lender"), which 2021 Note was scheduled to mature on July 22, 2022.

At the City's request and pursuant to the Act, the Lender has offered an additional

extension of the term of the 2021 Note to May 22, 2023, subject to an increased interest rate of 3.5%, which may be extended and/or renewed upon the mutual agreement of the Lender and City, and subject to an interest only payment on the 2021 Note, the balance of which to be determined on the date of the original issue of the Amended Note, which offer is attached hereto as **Exhibit A** (the "**Extension**").

7. To effectuate the Extension, the 2021 Note must be amended and approved, the form of which is attached hereto as **Exhibit B** (the "<u>Amended Note</u>").

8. It is necessary and in the public interest to approve the Extension, as reflected in the Amended Note, and to authorize the Mayor and City Clerk of the City to execute the Extension, the Amended Note and other documents necessary to effectuate the purposes of this Extension Resolution, and to make an interest only payment on the 2021 Note, and to ratify and approve their actions heretofore taken.

9. That it is in the best interest of the City to employ and authorize the law firm of Butler Snow LLP, Ridgeland, Mississippi, as Note Counsel, Ginger Miller, Esquire, as Counsel to the City, to prepare and distribute such resolutions, certifications and documents necessary in order to facilitate the Extension and the Amended Note.

### NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY, ACTING FOR AND ON BEHALF OF THE CITY, AS FOLLOWS:

**SECTION 1.** This Extension Resolution is adopted by the Governing Body of the City pursuant to the Act, the 2021 Note and the Amended Note, and all matters and things recited in the premises and preamble of this Extension Resolution are found and determined to be true and accurate.

**SECTION 2.** The Governing Body hereby accepts and approves the terms and conditions of the Extension attached hereto as **Exhibit A**, and the form of the Amended Note reflecting the same attached hereto as **Exhibit B** and directs to the Clerk to forward the executed Extension, Amended Note, and a certified copy of this Extension Resolution to the Lender.

**SECTION 3.** The Governing Body hereby authorizes and directs the Mayor or the City Clerk to approve an interest only payment on the balance of the 2021 Note, as requested by the Lender in the Extension, the balance of which will be provided by the Lender on the date of execution of the Amended Note.

**SECTION 4.** The Mayor and the City Clerk of the City, and their actions heretofore, are hereby ratified, and they are authorized and directed for and on behalf of the City to take any and all such action as may be required by the City, to carry out and to give effect to the Extension and the Amended Note authorized pursuant to this Extension Resolution and to execute the Extension, the Amended Note, and all papers, documents and certificates that may be required to effectuate the purposes of this Extension Resolution.

SECTION 5. Except as provided herein and in the Amended Note, the 2021 Note and the Note Resolution and the terms therein remain in full force and effect.

**SECTION 6.** The interest on the Amended Note is <u>not</u> exempt from Federal income taxes under existing laws, regulations, rulings and judicial decisions with such exceptions as shall be required by the Code. Under existing law, interest on the Amended Note is exempt from present taxes imposed by the State of Mississippi (the "<u>State</u>") and any city, municipality or other political subdivision of the State, except for inheritance, estate and transfer taxes.

**SECTION 7.** The Governing Body hereby authorizes and directs the Mayor to approve the payment of costs incidental to the issuance of the Amended Note, including but not limited to the payment of legal fees, which may be paid from proceeds of the Amended Note.

SECTION 8. The Mayor and the City Clerk of the City or any other officer of the City are hereby authorized and directed for and on behalf of the City to take any and all such action as may be required by the City, to carry out and to give effect to the aforesaid Amended Note authorized pursuant to this Extension Resolution and to execute all papers, documents and certificates that may be required to effectuate the purposes of this Extension Resolution, the Extension and the Amended Note.

**SECTION 9.** All orders, resolutions or proceedings of the Governing Body in conflict the provisions of this Extension Resolution shall be and are hereby repealed, rescinded and aside, but only to the extent of such conflict.

**SECTION 10.** For cause, this Extension Resolution shall become effective immediately upon the adoption thereof.

On July 22, 2021, the City of Senatobia, Mississippi ("City") issued the 2021 Note to Guaranty Bank & Trust for the purpose of obtaining interim financing in anticipation of a loan commitment from the United States Department of Agriculture, Rural Utility Service ("USDA") dated June, 1, 2021, and September 23, 2019, which loan proceeds are for constructing and improving a water treatment facility in the City. The 2021 Note matured July 22, 2022. The project has been delayed, and USDA has not approved making the final loan to the City to pay off the 2021 Note. Consequently, the City has asked that the maturity for the 2021 Note be extended until May 22, 2023. 2021 Note. Co May 22, 2023.

In response to such request, Guaranty Bank & Trust hereby extends the maturity of the 2021 Note to May 22, 2023, subject to increasing the rate to a fixed rate of 3.5%, with the same terms and conditions as specified in the Renewal Letter. We hereby request the City to provide an Amended Note with the extended maturity date of May 22, 2023 at a fixed rate of interest of 3.5%.

In addition, Guaranty Bank & Trust hereby requests the City to make an interest only payment on the 2021 Note for interest accrued during the initial term. As of the date of this letter, the interest only payment balance is \$54,613.65. Upon execution of the Amended Note, we will update the interest only payment balance as of the date of the execution of the Amended Note.

Interest shall be computed and shall accrue at the rate of 3.500%, and such interest shall be payable in arrears on (i) the date(s) of each advance hereunder, (ii) on each anniversary date of the Amended Note, and (iii) upon maturity, until said principal sum shall have been paid in full. Interest shall be calculated on the basis of actual days elapsed and a 360-day year, and shall not exceed that allowed in Section 75-17-107, Mississippi Code of 1972, as amended from time to time.

The Amended Note is subject to redemption prior to its stated date of maturity, in whole or in part, at any time, at par, plus accrued interest to the date of redemption. The entire remaining outstanding principal balance of the indebtedness evidenced by this Amended Note, together with all accrued and unpaid interest thereon, if not sooner paid, shall be due and payable in full on May 22, 2023, provided, however, this Amended Note may be extended and/or renewed for a term not exceed that allowed by the Act upon the mutual agreement of both parties.

All payments of principal, interest and other amounts payable on or in respect of this Amended Note or the indebtedness evidenced hereby shall be made to the Lender at its principal office in Belzoni, Mississippi, in lawful money of the United States of America, in funds immediately available to the Lender as the Lender may from time to time direct.

This Amended Note evidences a non-revolving line of credit by the Lender in favor of the City, and, accordingly, the City shall have the right to obtain advances of principal hereunder during the term of this Amended Note, up to a maximum aggregate principal amount equal to \$9,660,000; provided, however, that the Lender shall have no obligation to make any further

advances hereunder in the event that an event of default shall have occurred and be continuing. Such advances and re-advances may be made by the City without notice to or consent of any other person or entity. The amount of each advance will be submitted to the Lender by the Mayor or City Clerk of the City, in substantially the same form attached hereto as **EXHIBIT A**, and the signature of the Mayor or City Clerk of the City shall be affixed in witness of each such advance in the place provided therefor.

This Amended Note is the Amended Note issued in the aggregate authorized principal amount of not to exceed Nine Million Six Hundred Sixty Thousand Dollars (\$9,660,000), to raise money for the purpose of providing interim financing in anticipation of receipt of proceeds of the Loan from the United States Department of Agriculture - Rural Utilities Services ("USDA-RUS") dated September 23, 2019, as amended as amended June 2, 2021, (the "Loan"), to defray the cost of (i) improving, repairing and extending the combined water, sewer and gas system of the City, as referenced in the Loan, (ii) for other related improvements; and (iii) the payment of expenses incidental to the issuance of the Amended Note, all as authorized under the Act.

This Amended Note is issued under the City of the Constitution and statutes of the State of Mississippi, including the Act, and by the further City of proceedings duly had by the Mayor and Board of Aldermen of the City, including the resolutions adopted on April 6, 2021 (the "Note Resolution"), May 18, 2021 (the "Sales Resolution") and August 16, 2022 (the "Extension Resolution" and together with the Note Resolution and the Sales Resolution, the "Resolution").

The Lender may, at any time, sell, transfer or assign this Amended Note and/or participation interests in this Amended Note.

IT IS HEREBY CERTIFIED, RECITED AND REPRESENTED that all conditions, acts and things required by law to exist, to have happened and to have been performed precedent to and in the issuance of the Amended Note, in order to make the same a legal and binding limited obligation of the City, according to the terms thereof, do exist, have happened and have been performed in regular and due time, form and manner as required by law.
