Utility Adjustment Discussion (tabled from 6.6.23)

Mayor Graves advised the Board that this item was tabled at the last Board meeting. Mayor Graves stated that we previously adopted a policy with a unanimous vote, it was later changed with a 3/2 vote. That motion was vetoed. I would like to have a unanimous vote on this policy, for everyone to be on the same page, since the initial policy was adopted with a unanimous vote.

Alderman Dear stated I didn't think pools were included in the policy approved.

Mayor Graves stated it was in the minutes.

Alderman Moore stated it was in the minutes. Alderman Hale asked a question regarding the pools, then no discussion was noted in the minutes after that. I think something should be in there for adjustments for services not rendered.

Mayor Graves stated what if someone is just watering their yard.

Alderman Simpson stated what about them getting an irrigation system.

Alderman Tanksley stated having a pool is an expensive investment.

Alderman Moore stated there are different situations. Some may only fill their pool one time in 10 years, some may keep having issues and have to fill up 3 or so times a year.

Alderman Simpson stated Some have a septic system, some drain the pool water in their yard, some drain it in the sewer system. We have to charge for the sewer based on the water used. We

don't have a separate sewer meter. We all know the city was bleeding money, losing money. We can't just do something for a certain group of people.

Alderman Moore stated I agree with Alderman Simpson on that for a leak. I don't think someone who doesn't use the service should have to pay for it.

Alderman Simpson stated I don't think we can have a motion, that would be the same, without a full vote. There was a veto, and it lay there, nothing was turned in for it.

Alderman Moore stated so it's a moot point.
